Umpires in our leagues will need to wear the following uniform: Baseball: Navy Shirt, gray pants, black shoes. (USSSA); Softball: Red shirt, gray pants, black shoes. (USSSA). All umpires will need to provide their own equipment (face mask, shin guards, chest protector, plate brush, and clicker).
